Call to Order: Mayor Jaspers called the meeting to order at 5:30 p.m.

**Agenda:** German moved and Solberg seconded to adopt the agenda as presented. All voted aye.

**Ordinance 675:** Solberg moved and Stapleton seconded to pass the second reading and adoption of Ordinance 675 – AN ORDINANCE ENTITLED, AN ORDINANCE TO: AMEND ORDINANCE 17.04.040 “DEFINITIONS” OF THE ZONING ORDINANCE OF THE CITY OF SISSETON;  
TO AMEND CHAPTER 17.24 [DISTRICT REGULATIONS] TO ADD PROHIBITED USES UNDER SECTION 17.24.020 H.;  
TO AMEND SECTION 17.44.010, “PERMITTED USES” [C1 – CENTRAL COMMERCIAL DISTRICT];  
TO AMEND SECTION 17.48.010, “PERMITTED USES” [HC – HIGHWAY COMMERCIAL DISTRICT];  
TO AMEND Chapter 17.80 “SUPPLEMENTAL REGULATIONS”.

Upon roll call vote, voting aye were Appel, Just, Stapleton, Solberg and German. Randolph absent. Motion carried.

**Ordinance 676:** Solberg moved and German seconded to pass the second reading and adoption of Ordinance 676 – AN ORDINANCE ADDING CHAPTER 5.40 TO THE REVISED ORDINANCES OF THE CITY OF SISSETON CREATING LICENSING PROVISIONS FOR CANNABIS ESTABLISHMENTS

**Cannabis Establishment License Application Form:** Stapleton moved and Appel seconded to approve the application form for Cannabis Establishment Licenses. All voted aye.

**Coronavirus Local Fiscal Recovery Fund Registration:** Just moved and German seconded to authorize registration for the Coronavirus Local Fiscal Recovery Fund to access funds available through the American Rescue Plan Act and to authorize Mayor Jaspers to sign Financial Assistance Agreement and Assurances of Compliance associated with the Coronavirus Local Fiscal Recover Fund. All voted aye.

**Ordinance 678:** Appel moved and Just seconded to pass the first reading of Ordinance 678 – AN ORDINANCE ESTABLISHING ANNUAL SALARY AND WAGE LEVELS FOR THE PRINCIPAL EMPLOYEES AND OFFICIALS OF THE CITY OF SISSETON.
